- 6. Sealed of electronic bids must be submitted to the office of Belbari Municipality, belbari, Morang through web portal www.bolpatra.gov.np/egp. On or before 12:00 0n 23/02/2021. Bids received after this deadline will be rejected.
- 7. Technical bids will be opened electronically and physically immediately in the presence of Bidders representatives, who choose to attend at 14:00 on 23/02/2021 specified above at Belbari Municipality, Belbari. Bids must be valid for a period of 120 days for all contracts, after bid opening and must be accompanied by bid security validity for at least 30 days beyond the bid validity period respectively.
- 8. If last date of pre-bid meeting/purchasing/submission day falls on a government holiday, then the next working day shall be considered as last date. In such case the validity period of the bid security remain the same as specified for the original last date of bid submission.
- 9. After the completion of evaluation of technical bids, which are substantially responsive bidders, will be invited to attend the opening of price bids. The date, time and location of opening of price bids shal be notified in written and/or published in national daily.
- 10. Other information not mentioned above is as per public procurement act 2063 and public procurement regulation 2064 with last amendment.
